

GARBAGE SERVICE

Commencing from 15 January 2008 tariffs for garbage service within the port of Trieste are established as follows:

A) Basic rates due for each service rendered to:

1 - Merchant ships berthed in the port of Trieste:

ship up to	500	G.R.T.		Euro	13,00
from	501	a	1.000	G.R.T.	Euro 23,00
from	1.001	a	4.000	G.R.T.	Euro 46,00
from	4.001	a	10.000	G.R.T.	Euro 50,00
from	10.001	a	15.000	G.R.T.	Euro 62,00
from	15.001	a	30.000	G.R.T.	Euro 77,00
from	30.001	a	50.000	G.R.T.	Euro 88,00
from	50.001	and over	G.R.T.	Euro	95,00

B) Basic rates to be paid per day or fraction for:

1 - Stay alongside vessel of floating crafts or containers suitable for the collection of garbage:

floating craft	Euro	74,00 / per hour or part
15 cbm container	Euro	85,00 / per day or part
24 cbm container	Euro	138,00 / per day or part
34 cbm container	Euro	199,00 / per day or part

2 - Clearance of barges or containers upon completion of service:

emptying of one 15 cbm cont.	Euro	345,00
emptying of one 24 cbm cont	Euro	556,00
emptying of one 34 cbm cont.	Euro	702,00

3 - Upon ship's request a lorry may be supplied for collection of dunnage and hold waste (special waste):

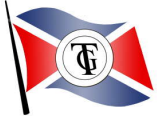
dunnage / hold waste	Euro	49,95 / mc

C) Surcharge and rebates:

1 - To services rendered to passenger ships at anchorage, that have no passengers aboard, rates shall be applied whereas at point 1 of paragraph A).

2 - For services to Italian men-of-war: 30 % rebate

3 - For services rendered during working days between 17.00 and 08.00, upon ship's request: 50 % surcharge

| 4 - For services rendered on holidays between 08.00 and 17.00: | 70 % surcharge |
| 5 - For services rendered on holidays and Saturday before 08.00 and after 17.00, on ship's request: | 100 % surcharge |
| 6 - For services rendered to ships in dry-dock: | 20 % surcharge |
| 7 - For services rendered to ships on roads: | 20 % surcharge |
| 8 - If the garbage is collected by dustmen: | 25 % surcharge |

Chapter II° Rules for the collection of waste produced by ships staying in Trieste port or roadstead.

Article 8: (use of ship's incinerator)

In the areas under the jurisdiction of the Marine Department of Trieste, ships are prohibited to use their incinerator intended to the elimination of produced waste.
